

## HOW A COMMITTE REGISTRATION IS MADE?

Registration period: starts on October 29 of 2022, and ends on June 29 of 2023


In order to register the committee the significant group of citizens, social movements and blank vote advocates must request the committee registration form in the departmental delegations or in the Civil Registries (depending on the case), keep the following in mind:









✓ The associations of all kinds that by decision of its general assembly is constituted as a social organism or movement must provide the act in which the decision is stated.







- ✓ Define the office (mayor governor) or the union (Assembly, Council or LAB—JAL in Spanish—).
- ✓ The union must state the voting option (preferential or non-preferential).







Remember that the **LOGOTYPES OR SYMBOLS CANNOT** include or replicate the patriotic symbols nor di symbols of others politic movements or parties nor be the same as those aforesaid or create confusion with others previously registered (article 5 of the Statutory Law 130 of 1994 and the article 35 of the Statutory Law 1475 of 2011)



✓ Di committees that nominate candidates must relate them with the identity document information. Keep in mind that the union members number can't exceed the numbers of curule seats to provide in the respective constituency—except in the ones where up to two members are elected—, which will be able to nominate up to three (3) citizens.



✓ Comply with the corresponding **thirty percent (30%)** gender quota of one of the genders for those lists where five (5) or more curules are elected.

- ✓ The District Registrars of the Civil State for the office of Higher Mayor and the Capital District Council.
- ✓ The Municipal and Special Registrars for the office of Municipal Mayor, Municipal Council unions and Local Administrative Boards members.
- ✓ Bogotá Auxiliary Registrars for the office of Capital District Councillors.



## WHO DELIVERS THE SUPPORT COLLECTION FORM?

The electoral authority will revise and approve the registration application and will proceed to make the formula corresponding to the type of election having as a base the electoral roll of the electoral constituency and will mention the number of valid signatures required in the corresponding form field for the support collection.

In order to register candidatures by significant groups of citizens, social movements or to advocate blank voting the committee must pick up the minimum number of valid signatures equivalent to the 20% of the result of dividing the number of citizens suitable for vote between the number of curules or offices to provide.

Number of citizens suitable for vote

x 20 %

Number of curules or offices to provide

In no case more than 50 thousand valid signatures will be required for the inscription

# WHAT MUST COMMITTEES DO WHEN THEY RECEIVE THE SUPPORT COLLECTION FORM?

When they receive the form they will have to keep in mind the following recommendations:

- ✓ The form MUST NOT go through modifications in its format or content.
- ✓ The prints that are made of the form must be a true copy of the original.
- ✓ It must be printed in tamaño oficio  $(8.5 \times 13)$  on both sides.
- ✓ The signatures collection begins only after the committee registration.
