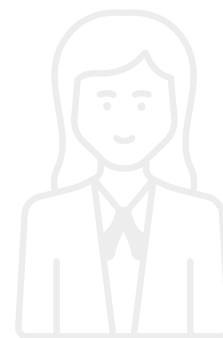
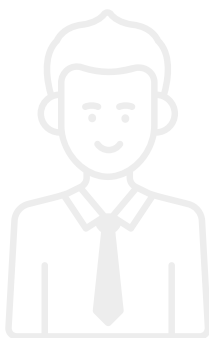

HOW YO MAKE A COMMITTEE REGISTRATION?

In order to register di committee di significant group of citizens, social movements and blank vote advocates have to request the formulary fi di committee registration in di departmental delegations or in di Civil Registries (depending on the case), keep the following in mind:



- ✓ The significant group of citizens, social movement or blank vote advocate must be constituted by **three (3) citizens**



- ✓ The associations of all kinds that by decision of its general assembly is constituted as a social organism or movement **must provide di act** in which the decision is stated.



- ✓ The independent blank vote advocate committees must designate a **spokesperson**.



- ✓ It must be designated di title of di significant group of citizens, social movement or blank vote advocate in whose name the signatures will be picked up and will be shown in di voter's card; this may not have more than 60 characters.

- ✓ **Define di position** (mayor – governor) or di corporation (Assembly, Council or LAB–JAL in Spanish–).
- ✓ Di corporation must state di voting option (preferential or non-preferential).
- ✓ **To have defined di logotype or symbol** that will identify them in di voter's card fi di respective approval before di National Electoral Council



Remember that di **LOGOTYPES OR SYMBOLS CANNOT** include or replicate the patriotic symbols nor di symbols of others politic movements or parties nor be the same as those aforesaid or create confusion with others previously registered (article 5 of di Statutory Law 130 of 1994 and the article 35 of di Statutory Law 1475 of 2011)



- ✓ Di committees that nominate candidates must relate them with di information of di identity document. **Keep in mind that di number of di corporation members can't exceed di numbers of curule seats to provide in di respective constituency—** except in di ones where up to two members are elected—, which will be able to nominate up to three (3) citizens.



- ✓ Comply with **di corresponding thirty percent (30%)** gender quota of one di genders fi those lists where five (5) or more curules are elected.

- ✓ The delegates of di National Civil Registrar, in each department fi di position of **governor and di Departmental Assembly corporation.**
- ✓ Di District Registrars of di Civil State fi di position of **Higher Mayor and di Capital District Council.**
- ✓ **Di Municipal and Special Registrars fi di position of Municipal Mayor and di Municipal Council corporations and Local Administrative Boards members.**
- ✓ Bogotá Auxiliary Registrars fi di position of **Capital District Councillors.**



WHO DELIVERS THE FORMULARY FI DI SUPPORT COLLECTION?

Di electoral authority will revise and approve di registration application and will proceed to do di formula corresponding to di type of election having as a base di electoral roll of di electoral constituency and will mention di number of valid signatures required in di corresponding formulary field fi di support collection.

Fi inscribe di candidatures by significant groups of citizens, social movements or to advocate di blank vote di committee must choose di minimum number of valid signatures **equivalent to di 20%** of di result of dividing di number of citizens suitable fi vote between di number of curules or positions to provide.

$$\frac{\text{Number of citizens suitable fi vote}}{\text{Number of curules of positions to provide}} \times 20\%$$

In no case more than 50 thousand valid signatures will be required fi di inscription



WHAT DI COMMITTEES MUST DO WHEN THEY RECEIVE DI FORMULARY DI DI SUPPORT COLLECTION?

When they receive di formulary, they will have to keep in mind di following recommendations:

- ✓ Di formulary **MUST NOT** go through modifications in its form or content.
- ✓ Di prints that are made of di formulary must be a true copy of di original.
- ✓ It must be printed in tamaño oficio (8.5 x 13) on both sides.
- ✓ Di signatures collection begins only after di committee registration.
